Other issue specialties included congressional organization and procedures. One important contribution was the package of congressional reform ideas presented in fall 1994 by House Republicans.

I was also the congressman's chief political and legislative advisor in his transition and first year in office.

As director of research and deputy staff director (March 1991-January 1993), I managed and edited committee projects and publications and served as assistant press secretary. My major research areas were health care policy, the flat income tax, and federal "luxury" taxes.
